My teaching strategy and philosophy is closely intertwined with my vision and approach to research and practice. In this context I support and promote research-oriented learning (Forschungsorientiertes Lernen)

My ultimate goal is to assist students and young researchers to unfold their maximal potential availing them with open and reflected modes of thinking and providing them with the necessary capacities and instruments so that they are able tackle complex problems (as they are very common in the urban field) through innovative approaches.

In this way I seek prepare the graduates and young researchers for national and international careers within and beyond the traditional discipline

At the core of my modus operandi is a problem based approach seeking to identify the core problems and to delineate coherent questions and methodologies. This often necessitates open, adaptable, process based, integrated and inter- and trans-disciplinary modes of work

It is vital for me to teach at eve level with the students and to develop the teaching contents based on the existing level of experience that is present in the group

I find it essential to involve students early on in research activities to familiarise them with basic research methods in the urban field

I strongly prefer active over passive forms of learning promoting case study based group work and discussions in combination with lectures and instruction to large groups

I opt for a mix of classical instruction formats (including basic research and writing techniques) with experimental methods and instruments such as, story lines as a design tools, rule based planning techniques, or scenario based approaches

As part of the problem oriented tactic it is vital to be exposed to and to collaborate with other disciplines (representing different philosophies and tools), as well to collaborate with stakeholders "clients" and partners on the ground.

- It is very important to me always to include a level of self-reflection and internal learning/ monitoring to all teaching formats to ensure that learning processes actually occur.
- Not least the documentation and dissemination of the work and the results is vital

As a result my approach to teaching aims at the development of the following capacities and skills:

- Reflective knowledge base on global urbanisation processes
- Mastery of an extended set methods of urban analysis and design (e.g. "multiscale" design tools, stakeholder and network analysis, scenographic approaches, scientific methods of analysis and assessment)

In times of imminent resource scarcity and decreasing public funds, new innovative approaches of regulating, projecting and funding of parks and public spaces are urgently needed. It emerged in the context of an ongoing artistic documentation and research on newly emerging urban peripheries in rapidly changing cities in the global South. We examine here the production dynamics, the logic and effects of Cyberabad, the spatial transformation of a newly emerging technologically driven planned city extension in Hyderabad, India. The conclusion presents a catalogue twelve locally emerging urban types and six trends and drivers of a process of private urbanisation leading to a mixed and hybrid urban landscape — a landscape of surprise.

This publication and the embedded process of workshops and exhibitions made it possible to collaborate with German and Indian Colleagues form various disciplines such urban anthropology, political science and photography.
